GYNECOLOGIC CANCER GRANTS

Foundation for Women's Cancer (FWC) BRIDGES Accelerator Research Grants

Two 2026–2027 FWC BRIDGES Accelerator Research Grants are made possible by the Foundation for Women's Cancer to amplify the impact of BRIDGES research protocols.

Eligibility: Current or former SGO/GOG-F BRIDGES Scholars developing an interventional clinical trial under the mentorship of BRIDGES faculty mentors.

Allowable uses include:

- Preclinical studies supporting a proposed clinical trial (e.g., agent activity, tissue-based endpoints, toxicity/dose selection).
- Pilot studies to optimize instruments (e.g., survey validation, translated patient materials).
- Outreach to align protocols with community priorities (e.g., advisory boards, patient advocate engagement).
- Integration of correlative studies to confirm on-target effects or identify biomarkers for phase II/III trials.
- Multisite expansion via collaboration with other BRIDGES scholars.
- Real-world data to inform trial design and clinical relevance.
- Other initiatives that accelerate launch or expand trial impact.

Two, one-year research grants of up to \$50,000 each

Foundation for Women's Cancer (FWC) Move4Her Research Grant

This grant is open to all gynecologic cancers.

Natera Research Grant Focused on Innovative Uses of Personalized Molecular Residual Disease Testing in Gynecologic Cancers

This grant application invites proposals for research projects that incorporate personalized Molecular Residual Disease testing (MRD) to advance the management of gynecologic cancers. Projects should focus on innovative uses of MRD in gynecologic cancers, including but not limited to:

- Prospective interventional or decision-impact studies to evaluate the clinical utility of MRD for optimizing treatment strategies in ovarian, endometrial, cervical, or other gynecologic cancers.
- Treatment monitoring studies utilizing ctDNA dynamics to inform escalation, de-escalation, or switching of therapy.
- Investigations of ctDNA as a surrogate endpoint for treatment efficacy and/or survival in clinical trials.
- Evaluation of the potential of MRD-guided interventions to reduce overtreatment or toxicity, including financial toxicity.
- MRD-guided surveillance studies that utilize ctDNA dynamics to inform imaging and/or treatment escalation.

Priority will be given to prospective, interventional designs that explore the value of MRD-informed care for patients with gynecological cancer. Proposals that focus on MRD feasibility/detectability in gynecologic cancer and/or general prognostic value of MRD in gynecologic cancers will be given less priority.

Investigators with biobank-related project proposals may contact Natera directly by filling out a Natera Sponsored Trials research form. Biobank study criteria are listed below:

- Serial timepoints available, with >5 mL of plasma collected and banked per timepoint.
- Tumor tissue available for assay development and analysis.
- Matched normal whole blood or other sample types that allow for germline analysis.
- Clinical follow-up data available to enable correlation of MRD results with interventions and outcomes.

This grant is open to all gynecologic cancers.

OVARIAN CANCER GRANTS

Amy Krouse Rosenthal Foundation Research Grant for Early Detection of Ovarian Cancer

The Amy Krouse Rosenthal Foundation Ovarian Cancer Early Detection grant supports research in early detection and recurrence biomarker development.

The funded project must fall under one of the following areas:

- **Early detection of premalignant lesions** (including, but not limited to, serous tubal intraepithelial carcinoma (STIC)) through methods such as:
 - Serum/plasma analysis
 - Uterine lavage
 - Pap smears
 - Fallopian tube sampling
- **Biomarker development** for the early detection of ovarian cancer and/or ovarian cancer recurrence.
 - Identification of high-risk patients (including, but not limited to, BRCA or PALB2 mutation carriers) and methodologies for the early detection of ovarian cancer within these populations.
 - Biology of premalignant lesions/ early ovarian cancer.

\$72,500 one-year research grant

AstraZeneca Early Career Ovarian Cancer Research Grant

This award is designed to support promising fellows and early career faculty pursuing innovative research in ovarian cancer. The grant aims to foster the development of the next generation of investigators and provide critical support during the transition to research independence. Projects may encompass basic, translational, clinical, or population-based research relevant to the prevention, diagnosis, treatment, or outcomes of gynecologic cancers with additional consideration for proposals with emphasis on DNA damage response (DDR), immuno-oncology (IO), and antibody-drug conjugates (ADCs). Applicants should demonstrate a strong commitment to a career in gynecologic oncology research

and describe how the proposed work will advance their development as an independent investigator. Priority will be given to innovative projects with the potential to generate preliminary data and catalyze future research and extramural funding.

\$50,000 one-year research grant

GSK Early Career Ovarian Cancer Research Grant

This award is designed to support promising fellow and early career faculty pursuing innovative research in ovarian cancer. The grant aims to foster the development of the next generation of investigators and provide critical support during the transition to research independence. Projects may encompass basic, translational, clinical, or population-based research relevant to the prevention, diagnosis, treatment, or outcomes of gynecologic cancers. Applicants should demonstrate a strong commitment to a career in gynecologic oncology research and describe how the proposed work will advance their development as an independent investigator. Priority will be given to innovative projects with the potential to generate preliminary data and catalyze future research and extramural funding.

\$75,000 one-year research grant

National Ovarian Cancer Coalition Health Equity & Diversity Research Grant

The National Ovarian Cancer Coalition is proud to announce their one-year grant to support innovative research focused on addressing health disparities and advancing equity in ovarian cancer prevention, diagnosis, treatment, and survivorship. Priority will be given to projects that explore the impact of social determinants of health, improve access to care, and promote diversity and inclusion in ovarian cancer research. Innovative Approaches to Malignant SBO Research Grant in loving memory of Irina Rozentsveyg

This award supports innovative research to improve outcomes for patients with advanced ovarian cancer complicated by malignant bowel obstruction, a devastating condition that can limit or preclude further cancer-directed therapy. The award also encourages innovative therapeutic, procedural, supportive-care, or multidisciplinary strategies that prevent or relieve obstruction and enable patients to receive or continue effective cancer-directed treatment. Research addressing the biology of malignant bowel obstruction is encouraged when it may identify direct mechanisms or targets for preventing or managing obstruction, including factors related to peritoneal disease, fibrosis, and intestinal dysfunction.

We invite **innovative, multidisciplinary proposals** that apply new concepts from gynecologic oncology, surgery, gastroenterology, interventional radiology, biomechanics, biomedical engineering, materials science, and related fields. Projects may include laboratory, computational, engineering, preclinical, or early translational research. Areas of interest include:

- Novel surgical or minimally invasive approaches
- Innovative stents, devices, biomaterials, or drug-delivery systems
- Strategies to manage partial obstruction and prevent progression or preemptive approaches to prevent obstruction
- Approaches that may enable continuation or resumption of anticancer treatment
- Interventions that preserve bowel function, nutrition, and quality of life

\$100,000 one-year research grant

ENDOMETRIAL/UTERINE CANCER GRANTS

Farr Nezhat, MD Research Grant in Endometriosis

This grant supports innovative molecular profiling of endometriosis to identify dysregulated pathways that advance understanding of disease biology and reveal actionable targets for therapeutic development. The goal is to translate these discoveries into more precise and effective treatments that can augment and ultimately may reduce or replace the need for surgical intervention. The grant also seeks to deepen understanding of the molecular and precancerous linkages between endometriosis and endometriosis-associated ovarian cancers, particularly endometrioid and clear cell ovarian cancer.

\$100,000 one-year research grant

GSK Early Career Endometrial Cancer Research Grant

This award is designed to support promising fellows and early career faculty pursuing innovative research in endometrial cancer. The grant aims to foster the development of the next generation of investigators and provide critical support during the transition to research independence. Projects may encompass basic, translational, clinical, or population-based research relevant to the prevention, diagnosis, treatment, or outcomes of gynecologic cancers. Applicants should demonstrate a strong commitment to a career in gynecologic oncology research and describe how the proposed work will advance their development as an independent investigator. Priority will be given to innovative projects with the potential to generate preliminary data and catalyze future research and extramural funding.

\$75,000 one-year research grant

Wilma Williams Education and Clinical Research Grant for Endometrial Cancer

This grant supports research to improve outcomes for patients with high-risk and poor-prognosis endometrial cancer, including serous tumors and sarcomas. Priority will be given to studies that integrate precision-based tools and molecular diagnostics including ctDNA, genomic and gene-expression profiling, proteomics, and other emerging

technologies into clinical and translational research to improve risk stratification, guide treatment selection, monitor therapeutic response, and identify mechanisms of resistance.

MULTI-TYPE GYNECOLOGIC CANCER GRANTS

Genmab Research Grant Advancing Innovation in Ovarian and Endometrial Cancer

This grant focuses on understanding FR α expression levels throughout the disease trajectory of ovarian or endometrial cancer. Priority will be given to supporting research that enhances our understanding of folate receptor alpha (FR α) expression levels throughout the progression of ovarian and/or endometrial cancer. These insights could inform treatment decision-making and enable more precise patient stratification, ultimately improving clinical outcomes. Representation of underserved populations will be a highly valued feature in the review of submissions.

- Unmet needs in rare histologies across ovarian and endometrial cancer: real-world testing, monitoring, disproportional health outcomes in certain demographics, quality of life

\$50,000 one-year research grant

Institute for Surgical Excellence Surgical Innovation Research Grant

This grant will support the development of AI enabled web-based risk stratification tools to identify patients who may benefit from enhanced screening, risk reducing interventions, and preventative strategies for endometrial cancer. By integrating clinical and patient-specific risk factors with advanced imaging, including MRI and ultrasound, this project aims to improve individualized risk assessment, facilitate early detection and prevention, expand access to innovative diagnostic strategies, and improve outcomes for women in our underserved communities.

\$50,000 one-year research grant

Research Grant in Memory of Peggy A. Yates

This grant is open to all gynecologic cancers except ovarian cancer.

This grant supports innovative research to advance the early detection of gynecologic cancers through minimally invasive, accessible, and cost-effective approaches. Priority will be given to the discovery and validation of diagnostic biomarkers using readily obtainable biospecimens, including urine, vaginal or cervical samples, and blood, as well as emerging sampling technologies. The goal is to develop accurate, scalable screening strategies that enable earlier diagnosis and can be broadly implemented across diverse populations and care settings.

\$50,000 one-year research grant

Wendy R. Brewster MD, PhD Early Career Research Grant

Established in memory of Wendy R. Brewster, MD, PhD a beloved national leader, mentor, and advocate in gynecologic oncology, this grant supports fellows and physicians demonstrating success in the field of gynecologic oncology with their research in cervical or endometrial cancer research within the first two years following fellowship as they launch careers as physician-investigators. Funding provides protected nonclinical research time and research-related support to generate preliminary data and advance future independent investigation. Consistent with Dr. Brewster's legacy, research addressing health equity, disparities in cancer outcomes, and improved quality of care for all patients is particularly encouraged.

\$25,000 one-year research grant
